5. Nature and scope of work:

- a) The project is to conduct online coaching of CSE aspirants of 2026 batch of 26 SNT District Civil Services Study Centres.
- b) The duration of class is 7 (seven) months preferably. Total hours of class spread over the seven months period shall be 550 hours.
- c) The class will be conducted by the selected Institute in online mode. Satyendra Nath Tagore Civil Services Study Centre (SNTCSSC) will sponsor 26 District Study Centres which cover 50 students in each Study Centre.
- d) Selected bidder will provide coaching for the aspirants via on-line mode.
- e) Each subject wise nos. of hours of classes shall be decided mutually between CEPM and the selected bidder.
- f) Study material shall be provided in hard copy format to each student at each of the 26 centres by the selected bidder for each class.
- g) Further details about the operation of the classes shall be decided between the CEPM and the selected bidder mutually before commencement of the programme.

b) **Registration of Bidders:**

Any bidder willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-procurement System, through logging on the https://wbtenders.gov.in .The bidder is to click on the link for e-Tendering site as given on the web portal.

c) Digital Signature certificate (DSC) :

Each bidder is required to obtain a Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the Controller of Certifying Authorities (CCA) Govt. of India.

8. General terms of reference:

- a. Prospective bidders are required to submit their bids, including Earnest money, a Technical Presentation on their Academy/Institute/ Courseware etc. with timelines, and Institute credentials such as PAN, GST, Trade License, and audited accounts for the last three financial years.
- **b.** The successful bidder must obtain all necessary statutory approvals and clearances at their own expense.
- **c.** A provisional Letter of Intent (LoI) or Work Order will be issued to the successful bidder upon receiving approvals from the competent authority followed by MoU.

9. Requirements in Bidding Process:

- Bidders should familiarize themselves with the project area before submitting the bid.
- The Expression of Interest (EOI) must be comprehensive, including all necessary information and appendices, and submitted by the specified due date. The EOI should

be devoid of ambiguity or changes and must be signed on all pages by the authorized signatory of the organization.

- All bids, annotations, and accompanying documentation must be in the English language.
- Bidders are required to provide their complete address, along with telegraphic/phone/fax/mobile/email details in the bid document.
- The bid package should be submitted intact, and no alterations to the documents or their wording will be allowed.

11. Evaluation and Comparison of Bids:

• After opening the bids, the bid document submitted by each bidder will be examined. Any bid which does not fulfill the basic eligibility requirements set forth in Clause 10 of the EOI document will be rejected.

- Technical bid of the tenderers, who have fulfilled the basic eligibility criteria will be opened and evaluated.
- To assist in the technical evaluation of bids SNTCSSC may, at its discretion, ask a bidder for clarifications.
- Original documents will have to be produced by the bidders as and when asked by the bid screening committee.

- The Technical Bid will be evaluated by the selection committee constituted by SNTCSSC. Original documents will have to be produced by the bidders as and when asked by the bid selection committee. The financial bid will be assessed exclusively for bidders who have fulfilled the qualification criteria in the technical bid.
- The cost per participant for conducting Online Preliminary cum Mains foundation course for UPSC Civil Services Exam 2026 Batch should be specified. This cost per aspirant will exclude training for Optional subjects.
- If any document submitted by a bidder is either manufactured or false, in such cases the eligibility of the bidder will be outrightly rejected at any stage without any prejudice.
- The bidder quoting the L1 rate in the Financial bid shall be eligible for award of contract.

12. Tie Bid :

- a) During the evaluation of the financial bids of the technically qualified bidders, if it is found that more than one bidder quoted the same rate, then keeping the discovered L1 rate as ceiling, sealed bids may be invited from all the L1 bidders and out of those the lowest one may be selected.
- b) If none of the LI bidders is ready to offer further reduced rates, the work may be distributed equally among the consenting Ll bidders.
- c) If none of the L1 bidders is ready to accept reduced quantity, the bidder with higher credential based on the highest value of single work/ service of similar nature completed during last 3 years shall be considered.

13. Payment Schedule

The payment schedule to the selected bidder is as follows:

a) 1st instalment:

1/3rd of the gross value is payable at the end of 2^{nd} month after commencement of the course.

b) **2nd instalment:**

 $1/3^{rd}$ payment of the gross value is payable at the end of 4^{th} month after commencement of the course and also full satisfactory performance on the part of the selected bidder.

c) **3rd instalment:**

1/3rd payment of the gross value is payable at the end of 7th month i.e., after completion of Course period and also full satisfactory performance on the part of the selected bidder.

d) Performance Security Deposit:

Retention money towards performance Security amounting to 10% (ten percent) of the gross value of the bill will be deducted from each installment bill of the selected bidder. The security deposit shall be released at the end of the satisfactory performance by the selected bidder. No interest will be paid on security deposit.

The Selection Committee at SNTCSSC will review the progress of the course on monthly basis.
